Meantime, Councilman Chuck Rockel told council that village recreational facilities will be under additional pressure this year, because of Mariemont High School plans for a girls' soccer team which would use the field here. Along with the customary summer program here, he noted proposals for a men's softball team in the village, and plans for a pre-school recreational program in cooperation with the PTA.

He reported also that a formal survey of 10 acres which the committee is purchasing for a recreation area has been completed, but he said there was no possibility of those facilities begin brought into use this year.

Matthews Named As Fire Chief

A. Pierce Matthews Jr. is Terrace Park's new fire chief, succeeding F. Lee Stegemeyer who is leaving the village to take up a business opportunity in Savannah, Georgia.

Although Stegemeyer's resignation is not formally effective until the end of the month, Matthews was sworn in at the March council meeting following council's confirmation of his appointment by Mayor Ray Cadwallader.

His appointment followed screening by the safety committee of what the mayor called "several outstanding people" who submitted applications.

Matthews has been a member of the fire department for 10 years and an assistant chief for five years. He has been an active member also of St. Thomas Episcopal Church.

The Matthews family — Pierce and Pat — live at 132 Winding Brook. Their daughter Mimi, a fire buff like her father, was one of the first Terrace Park women to win state certification as a fire fighter, and with her father has been active also in Red Cross disaster work.

With Nutone for 18 years, Matthews is now on its consumer relations staff.

Following his appointment, the retiring chief was honored at a public reception at the Community House on March 18.

Mayor Cadwallader presented him with a citation for his years of work for the community. The fire department gave him a CB radio as well as his chief's badges and helmet as mementoes of his long service.

Village To Aid With Ambulance

Village council has agreed in principal to assist the volunteer fire department in acquiring a new ambulance.

Councilman Dick Bowman said at the March council meeting that he considered a new ambulance a high-priority item, but added that the village lacks funds to help at the moment.

The fire department has raised \$16,000 toward a new ambulance, expected to cost about \$25,000, to meet new requirements of the state and federal governments.

PTA Scholarship Applications Due

Applications for the \$200 scholarship awarded by the Terrace Park PTA are available at the office of the guidance director at Mariemont High School.

Any senior who is a resident of the school district and who attended Terrace Park elementary school, and holding a 2.5 average or better, is eligible.

Village council is planning to ask the voters in November to renew a present 6.5 mill levy and approve a new levy of 3.5 mills.

Reporting on a study of projected budgets for the next five years, Councilman Edward Harness told council at its March meeting that adoption of both levies is vital to continuation of village services. Formal action is expected at the April meeting.

Even at the moment, council was told, village expenses are running ahead of the current budget, largely because of snow removal expense, and the village likely will have to ask the county treasurer for an advance on the property tax yield.

If both levies are approved, Harness said the total increase to property owners would be 5.6 mills per \$1,000 of valuation. While the levy up for renewal is 6.5 mills, only 4.8 mills is being collected currently since a levy may only yield a dollar value based on property valuations in effect at the time the levy was passed. Valuations have been raised in a subsequent reappraisal.

Approval of both levies would give the village an additional \$42,000 for operating expenses. Harness said that village revenues have been increasing at a rate of less than 2%, while basic expenses have risen 7.5% mostly in payroll. Although he said he felt that village administration has been "conservative and hard-nosed," he said the only alternative to a tax increase was a severe cut in village services.

In other actions, council:

- Heard from Village Engineer Carl Lindell a report that the county has agreed to resurface Indian Hill Road. Interim patching is contemplated.
- Was told of Planning Commission rejection of a proposal to divide property at 614 Miami Avenue on the ground that there was insufficient frontage to meet requirements.
- Agreed to support a new application for greenbelt funds.
- Authorized the fire department to place a plaque on the firehouse in honor of deceased member Charlie Oberle.

The recipient will be selected in early April, and the award will be presented at the Terrace Park PTA meeting April 26.

New Moped Law Going Into Effect

New state laws governing the operation of motorized bicycles (mopeds) take effect April 1, and Police Chief Ron Pottorf is distributing summaries of the new rules.

The new regulations require that operators be 14 years or more in age, and hold either valid driver's licenses or special moped licenses issued to those between the ages of 14 and 18. No person under 14 is permitted to use a motorized bike on any public roadway or any private property used by the public for vehicular traffic or parking.

Although no driving test is required, those between 14 and 18 must pass a written test on motor vehicle laws and signs. The tests will be given at any State Highway Patrol driver license examination station, and no appointment is needed in order to take the test. With that test passed, an applicant may then obtain a license from any issuing agency, but a parent or guardian must accompany the applicant to sign the formal application.

A moped license, like a driver's license, can be suspended for violating motor vehicle laws.

While a moped operator must be licensed, no license or license plate is required for the moped itself.
